It is with great pleasure that I share with you the Transmission & Distribution Division's safety performance achievements during for 2018 and 2019 calendar years. According to the Safety Department's Safety Scoreboard Report, which tracks the occurrence of departmental lost-time accidents, in the St. Thomas-St. John District approximately 670 days have elapsed since the last reported lost-time injury in the T&D Division. Similarly, in the St. Croix District, about 909 days have passed since the previous reported lost-time injury in the T&D Division. This remarkable accomplishment is a result of our collective efforts to make great strides in improving safety culture in the Division through continuous training on safe work practices and policies, adhering to safety policies and procedures, and continually striving for operational excellence.

I would like to personally extend my appreciation and gratitude to all of you for the hard work and continued commitment to the Division's success and improving the safety culture. Collectively, we are on our way to achieving 36 months of operations without a reported safety incident in the St. St. Croix and 24 months of operations in the St. Thomas-St. John district. We should all be proud of the various ways we have contributed to this incredible accomplishment.

Line Departments, Automation and Operations, System Planning, Design and Construction, Substation, and T&D Administration personnel, you are appreciated.
