## Summary

The ESCC CEOs have convened an industry-wide Tactical Tiger Team (T3) to identify needs, priorities, gaps, and goals that address the challenges of operating the North American energy grid in a long-term pandemic environment.

The purpose of the group is to leverage asset owner and operator expertise to work through issues that are better solved collectively and with specific requests for support, as well as to share insights across the sector. The group will be comprised of "sub-teams" that will formulate specific action items and areas of coordination with government partners that are critical to business and operational continuity for asset owners and operators.

As this incident evolves, the focus of the T3 and "sub-teams" will be to address these challenges that emerge, given the dynamic nature of this global health emergency. As of March 13, 2020, the issue areas are grouped into the following sub-teams.

#### How we will coordinate?

Just as the ESCC does in "steady state," asset owners and operator leads are empowered to support each of the workstreams pursued by the T3 and sub-teams. The ESCC Secretariat (the trade associations) will facilitate and support this work by convening calls, compiling action items, and ensuring connectivity among the broad stakeholder community.

Twice weekly calls are scheduled (Mondays and Thursday at 11:15 a.m. EDT) for the full team, and a Groupsite workroom will house documentation and exchanged files. A semi-regular email blast will keep the sub-teams apprised of each other's efforts and output.

Each sub-team will self-organize under an industry lead and develop a coordination cadence.

#### Who is involved?

All segments of the sector, including IOUs, cooperatives, public power, independent power generators, gas distribution, ISO/RTOs, Power Marketing Administrations, ISACs, and Canadian partners. They will be represented both by trade associations and asset owners and operators. Our executive sponsor is Stan Connally, Executive Vice President for Operations, Southern Company Services.

#### What is the output?

Solutions, recommended practices, demand signals to other sectors or government partners focused on the big challenges. Input to the ESCC Resource Guide that will evolve with the situation. Additional information sharing and visibility into intra-sector and inter-segment collaboration.

## **Control Center Continuity**

Control centers are critical to keep staffed and operational. This team will address challenges of operating in a pandemic environment; topics including, but not limited to:

- Workforce shortages
- Cleaning and remediation
- Resilience and redundancy
- Waiver needs and other public policy considerations

#### **Accessing Quarantined and Restricted Environments**

Conducting operations and maintenance in restricted environments, or at the homes and facilities where there have been confirmed cases, raises challenges including, but not limited to:

- Waivers and access to restricted areas
- Industrial occupational safety guidance
- PPE protocols and availability
- Identification of essential employees and associated labor issues

#### **Supply Chain Challenges**

In this context, supply chain means both equipment and manufacturing shortages, as well as interdependent sectors on which the electric power sector relies (gas and telecommunications, primarily). Issues to consider include, but are not limited to:

- Identify and assess availability and priority of specific needs: equipment, PPE, commodities
- Long-lead time equipment and identification of critical assets
- Scenario planning to consider global supply shortages for extended periods (weeks? months?)
