Approval of the Newnan land Sale Proceeds to be Placed in the Board Restricted Reserve Fund

Walter West gave a brief update on the Newnan land sale. Walter stated the net proceeds from the land sale totaled \$465,622.63. Mr. West asked the Board to have the proceeds from the land sale to be placed in the Board Restricted Reserve Fund.

On motion by Tim Houston and seconded by Lamar Hill, the Board approved to have the net proceeds from the land sale totaling \$465,622.63 be placed in the Board Restricted Reserve Fund.

Approval of the Gresco Patronage Credits to be Placed in the Board Restricted Reserve Fund

Walter West informed the Board the 2022 Gresco Patronage Credits totaled \$257,100. From the total Gresco Patronage Credits, Mr. West asked the Board to consider allocating up to \$35,000 to help fund the ECG Annual Meeting. Mr. West recommended the remaining net proceeds of \$222,100 to be placed in the Board Restricted Reserve Fund.

On motion by Jeff Lewis and seconded by Lamar Hill, the Board approved to allocate up to \$35,000 from the Gresco Patronage Funds to help fund the ECG Annual Meeting with the remaining \$222,100 be placed in the Board Restricted Reserve Fund.
